INDICTMENT

THE GRAND JURY CHARGES THAT:

COUNT ONE

Between on or about October 15, 2008 to on or about November 30, 2008, in the Southern District of Texas and elsewhere within the jurisdiction of the Court, **Defendant,**

**ORLANDO JESUS HALE
AKA: CHACHO,**

did knowingly and intentionally conspire and agree with other persons known and unknown to the Grand Jurors to possess with intent to distribute a controlled substance. This violation involved a quantity in excess of 5 kilograms of cocaine, a Schedule II controlled substance.

In violation of Title 21, United States Code, Sections 846, 841(a)(1) and 841(b)(1)(A).

COUNT TWO

From on or about November 7, 2008 to on or about November 25, 2008, in the Southern District of Texas and elsewhere within the jurisdiction of the Court, **Defendant,**

**ORLANDO JESUS HALE
AKA: CHACHO,**

and other co-conspirators, known and unknown to the Grand Jury, aiding and abetting each other, did knowingly and intentionally:

- (a) carry and use a firearm, that is a semi-automatic pistol, the model and type unknown to the Grand Jury during and in relation to; and
- (b) possess a firearm, that is, a semi-automatic pistol, the model and type unknown to the Grand Jury, in furtherance of,

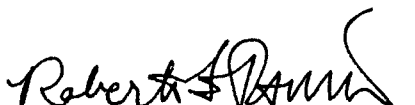
a drug trafficking crime which may be prosecuted in a court of the United States, that is, Conspiracy to Possess with Intent to Distribute a Controlled Substance as charged in Count One of the Indictment.

In violation of Title 18, United States Code, Sections 924(c)(1)(A)(i) and, Title 18 United States Code, Section 2.
