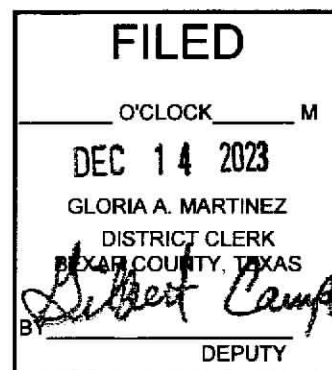

Paragraph A

on or about the 23rd Day of June, 2023, ALFRED FLORES, hereinafter called defendant, with intent to cause serious bodily injury to an individual, namely, MELISSA ANN PEREZ, did commit an act clearly dangerous to human life that caused the death of MELISSA ANN PEREZ, hereinafter referred to as complainant, by SHOOTING THE COMPLAINANT WITH A DEADLY WEAPON, NAMELY, A FIREARM;

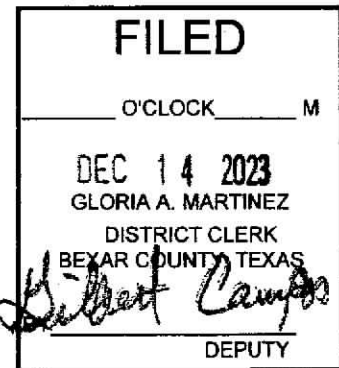

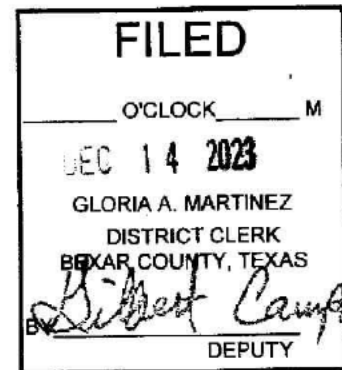
